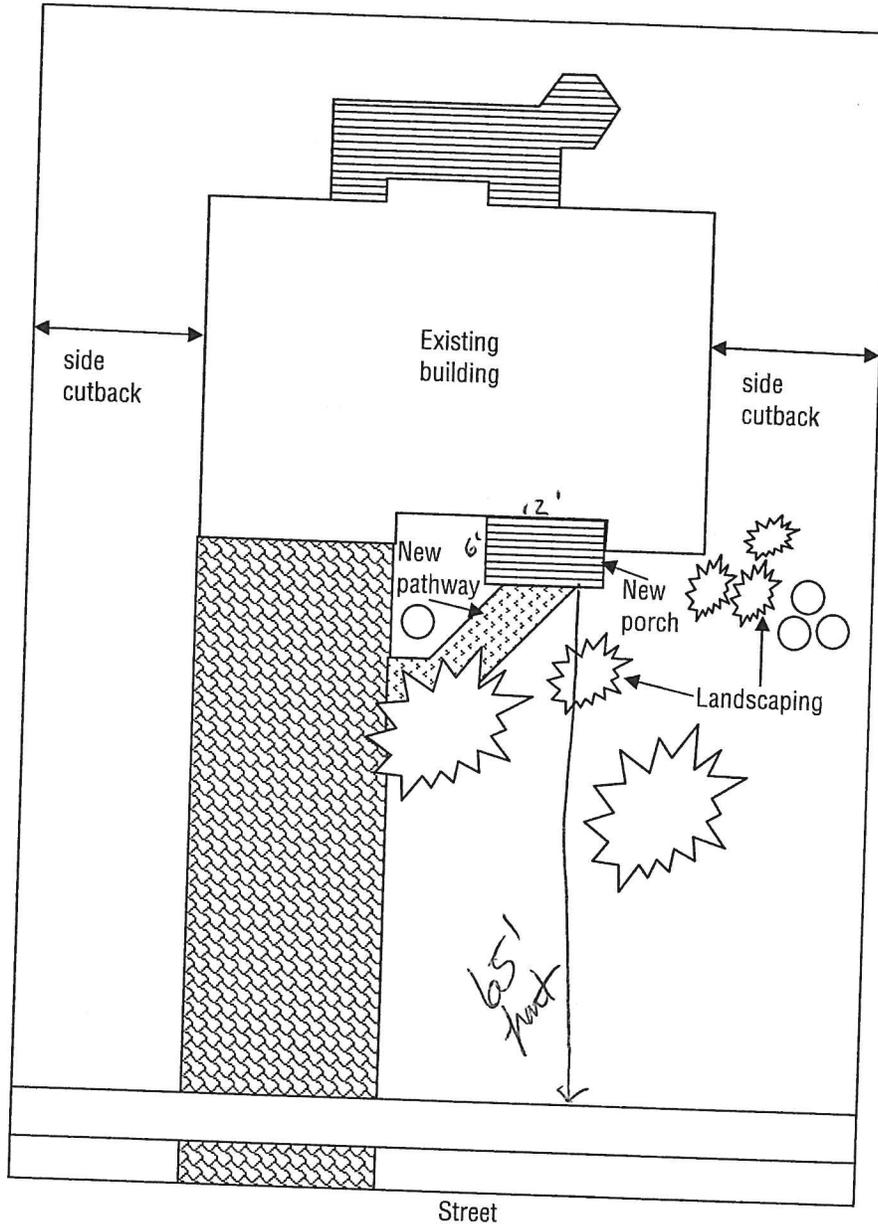

Porch: Approximately 12' wide and 6' deep front porch with shed roof over porch

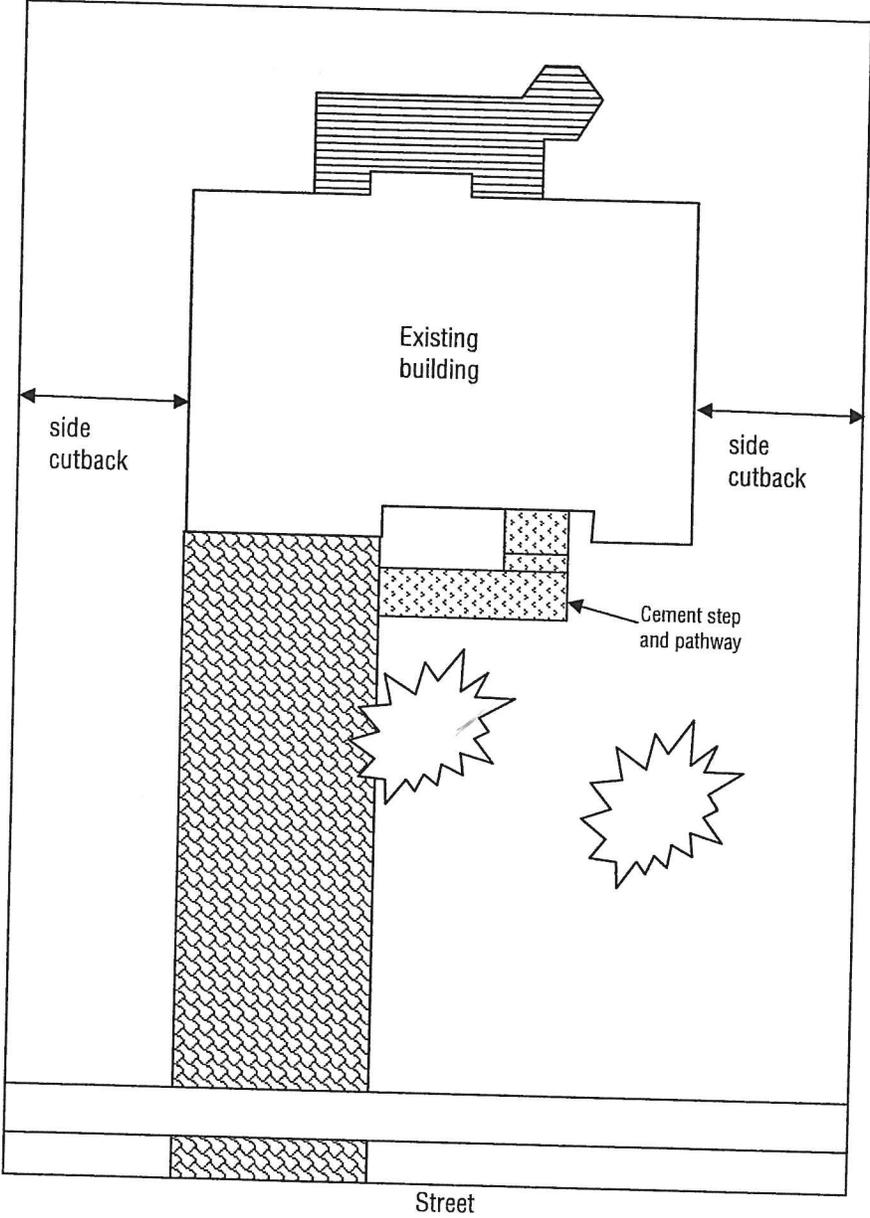
Deck Pathway: from porch to driveway
