- All applications for the Citizen’s Police Academy will be reviewed prior to acceptance into the program. Participants must be at least eighteen (18) years of age to apply.
- Class size will be limited to fifteen (15) participants.
- The academy will be run over the course of eight (8) weeks, with one (1) 3-hour class per week, for a total of twenty-four (24) training hours.
- Classes are expected to run on Monday evenings from 5:30pm - 8:30pm.
- If selected, participants will be notified via email or phone. Please indicate which method works best for you.
- Topics will cover a variety of laws, programs, law enforcement trainings and will include both demonstrations from support staff as well as hands-on activities.
- Photographs may be taken during the academy and may be used for promotional purposes on the Essex Police Department’s social media pages and/or website.
- Participants are asked to be courteous and respectful of both staff and fellow participants. Any actions or behaviors deemed inappropriate or viewed as a disruption to the class may result in being excused by staff for the duration of that academy and/or any future academy.
- Due to the subject matter of the profession, some subject material may contain graphic/disturbing images, videos or discussions. These types of content will only be presented as it relates to the subject/topic and the realities of law enforcement. If any participant has any concerns regarding the subject matter, please let staff know.
- At the completion of academy, participants will receive a certificate. Anyone wishing to participate in a ride along may request to do so.
